Nangmah bawmhnak hna kha chiah peng awkah nawlpatnak tuah colh!

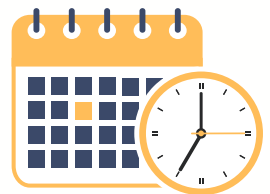
Hngak hlah! Nawlpatnak nawl na ngeihmi na sung kho. A hnudeuh ah naa let than kho peng.

Theihternak nithla in ni 15 chung ah nawlpatnak na tuah ahcun, nawlpatnak lei biakhiahnak tuah lio ah nangmah bawmhnak cu aa thleng lai lo.

Ni 15 hnu ah nawlpatnak na tuah khawh rih:

- Medicaid asilole tangka (TANF) caah ni **30** chungah nawlpatnak tuah
- SNAP caah ni **90** chungah nawlpatnak tuah

Fair Hearing Form

Hi form chung i a ummi tuah dingmi 10 hna kha tlamtling tein tuah khawhnak dingah lamhmuhnak pawl kha zul hna.

Nawlpatnak form phihnak ah tuah dingmi pawl:

- Theihternak nih bawmhna tampi a hnorsuan ahcun, a dihlak in form pakhat in nawlpatnak na tuah khawh.
- Zeiruanga dah na lungtlin lo ti kha CAO sinah chim: hihi cu “bawmhna hmuh awkah ka tlak” ti bantuk a si kho. A hnu deuh ah a dikthlir deuh in na chim khawh.
- Nawlpatnak a phi hngah lio ah nangmah bawmhna kha pehzulh na duh ahcun chim hna. A tlangpi in A **SI* (YES*)** tiah hmelchunhnak tuah dingin ruahnak kan in cheuh.*
 - *A hnu ah nawlpatnak na tuahmi na sung ahcun tihnung a um, cucu CAO nih hmuh awk na rak tlak lomi bawmhna pawl kha pek than dingin an in hal khawh.
- Hmaitonh thilsining kong chimphuannak asiloah telefon in thilsining kong chimphuannak ngeih khawhnak nawl na ngei. Mi nih CAO riantuantu a ummi hna he hmaitonh in thilsining kong chimphuannak tuah dingin ruahnak kan cheuh hna (a 4th checkbox thim khawhmi).
- Pumtlinlonak ruanga a hlei deuh in bawmhna na herh asiloah holhlettu na herh ahcun, form ah hi kong tialnak hmun a um. CAO nih man loin pumtlinglo umthutnak le holhlehnak rian a pek hna lai.
- Mi pakhatkhat nih nawlpatnak na tuahmi ah an bawmh ahcun, nangmah ai-awhtu sinak in nawlpatnak ah an konglam kha an chiah khawh.

Theihternak na hmuh lo hmanh ah, nawlpatnak na tuah khawh rih.

- Na nawlpatnak kha catlap a lawngmi cungah a sawhsawh tein tial.
- Na nawlpatnak kha chim, na min, CAO cazin khumhnak nambar asiloah zatlang himnak nambar kha chim, cun na minthutnak kha telh chih.

Na nawlpatnak ap ningcang:

- Na cazin chung khumh awk ah na nawlpatnak copy tuah, cun na umnak hmun CAO sinah nawlpatnak kha kut in kuat. Cabuai in “thlakmi” hmuhnak catlap kha ngah hrimhrim.
- Na CAO na ngah khawh lo ahcun, na nawlpatnak cu lehmat ngei cakuatnak halmi khirhthannak hmuhnak catlap hmangin na nawlpatnak cu kua.
